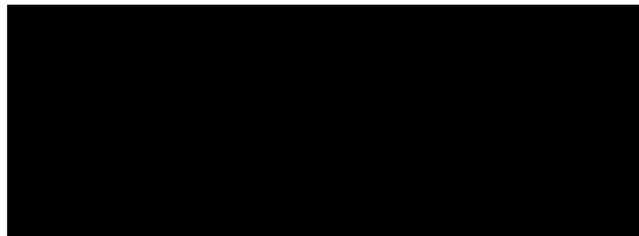
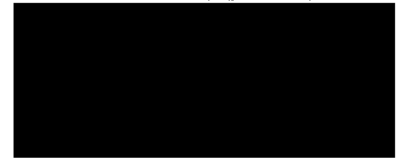



At the suggestion of  I am writing to you about the "contested" overpayment of mortgage interest on an additional loan under the Additional Costs Allowance.

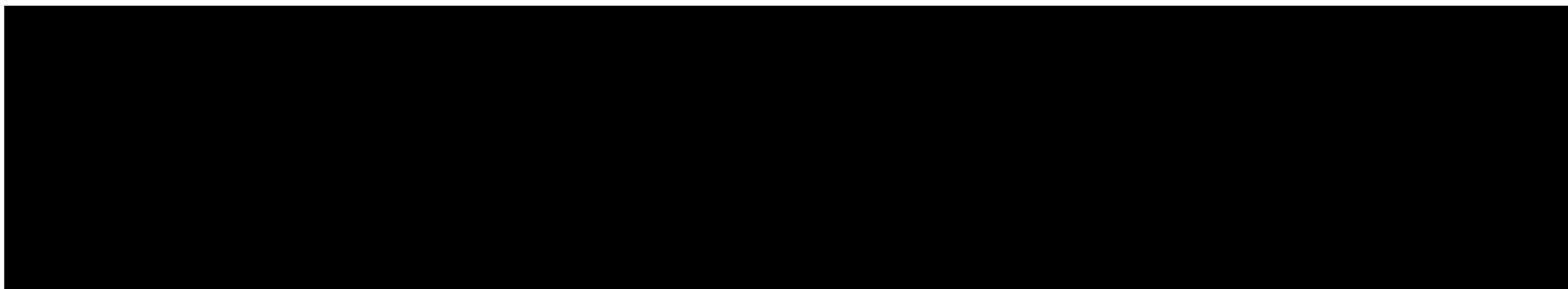
My argument is that I negotiated an additional loan at the time my 3-year fixed interest payment period came to an end at a total cost to the ACA for both the existing loan and new loan less than if I had remained on the new variable rate which was to come into force automatically.

Because this increased my mortgage outgoings (a fact I noted on my ACA claim at the time) was unable to claim all my allowances for the year 2005-06 within the total permitted allowance. This meant that legitimate costs such as Council tax and utility bills were not claimed in full for that year.

I therefore submit that there was no saving to be gained for the exchequer and that if, as I now accept the additional loan was not allowable and the Dept. of Finance has a duty to reclaim the overpayment retrospectively, then it would seem to be natural justice that I can retrospectively claim for legitimate costs incurred but not claimed in the appropriate year to offset this demand. All the appropriate figures are set out in my earlier correspondence.

I am enclosing my cheque for the "overpayment" of £1,203.19 for the financial year 2005-06 as requested but would respectfully suggest that I have a fair case for reconsideration, if not one strictly covered by the rules.

I am more than happy to be interviewed by a Speaker's panel or members of the Standards Committee if this is deemed necessary.
