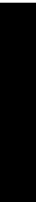
**Efficiency information**

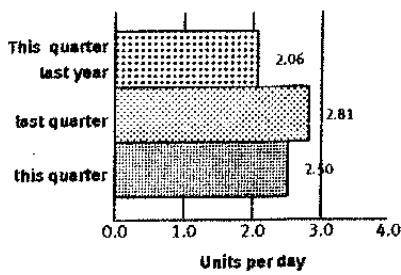
