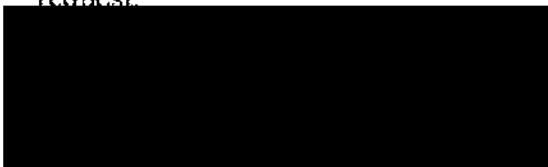
ACA Claim, Invoice [redacted] (£5293)
