An update from Amber Valley MP Judy Mallaber to her constituents

Honour the Brave

258 MPs have now signed Durham MP Kevan Jones' early day motion supporting the Daily Mirror's 'Honour the Brave' campaign recognising the bravery, dedication and sacrifice of our armed forces serving in Afghanistan and Iraq. Judy was an early signatory of the EDM which calls for all services personnel killed or wounded in enemy action to be awarded a medal.

Unsung heroes recognised

Thousands of women who worked hard to provide food and timber for the country during the Second World War have had their efforts acknowledged by the awarding of a badge of recognition.

Judy visits the Stroke Unit at the DRI

Judy is treasurer of the APPG on stroke which is serviced by the Stroke Association and has had a major input in to the recently launched national stroke strategy. Health Minister Ann Keen, herself a former nurse, addressed the last meeting. 110,000 people in England have a stroke each year and it is estimated that the stroke strategy could avoid up to 6,800 deaths and cases of disability each year.

Early treatment is critical and transfer of those with suspected stroke to a specialist centre. The Derby hospitals already have a dedicated acute stroke unit, rehabilitation stroke unit and one-stop TIA service for mini-strokes. A high proportion of patients for the one-stop TIA service are seen within one week and the majority within two weeks. On a recent visit, Judy met patient Ann Kosegi from Codnor Gate receiving treatment from occupational therapist Lauren Baker and physiotherapist Cilla White.

Also important is continuing support for stroke patients. Amber Valley Stroke Group meet fortnightly at St Joseph's Community Hall, Butterley Hill, Ripley to give support and undertake activities. For details contact Ida Buist on 01332 880579.

Another Group I am involved with is on solvent abuse. After meeting Nicollette Nicolle, a constituent whose son died as a result of sniffing solvents, I joined the Group so that I could play a part in raising awareness of this issue. Congratulations

To Somercotes Leisure Development Group, who after two years hard work, consultation and planning, have secured funding for the new Somerlea Park Community Centre. I was pleased to help lobby the Big Lottery, Derby & Derbyshire Economic Partnership and Coalfields Regeneration Trust who are putting in £750,000 for this new one stop shop facility for the local community. It will host a range of activities and be a focal point for the park and its sports. They plan to open the centre by the end of the year and hope to match Crossley Park in Ripley by securing Green Flag status for the park and

..... to Mortimer Wilson School for achieving arts specialist status to act as a local centre of excellence.

Quizzing Ministers in Transport Questions

"Four year old Finlay Martin was tragically killed last July when he was hit by a trailer that broke free from a car while he was walking in the village of Heage with his mother. The deputy coroner at the inquest just held said that she would write to the Department for Transport to ensure that lessons were learned. Will my honourable Friend investigate seriously the introduction of a mandatory test of road worthiness and an MOT for trailers that are pulled by road vehicles, and for such vehicles to have mandatory brake systems, which did not happen in this case? That has been requested by Finlay's grandparents and many of my constituents."

Replying to this question from Judy in the Commons and in subsequent discussions, Minister Jim Fitzpatrick made a commitment to investigate whether new regulations on trailers or other action could prevent tragedies such as the death of Finlay Martin where they result from faulty vehicles.

Although free local bus fares are being extended nationally, it seemed that Derbyshire's community transport scheme would be left out when the national scheme comes in. After raising the issue in Transport Questions, Judy and fellow Derbyshire MP Tom Levitt got a meeting for Derbyshire community transport services from Amber Valley and Ashbourne with Transport Minister Rosie Winterton. As a result of these discussions, it has been agreed that our dial a bus services can be covered with an amendment in the new Local Transport Bill - and the County Council are making money available to keep the service going in the meanwhile. At the time of writing discussions continue on other aspects of the concessionary fares scheme which will receive an extra £2 million in Derbyshire to cover the extra costs.
