Your mortgage is on a variable rate and is therefore affected by movements in our Standard Variable Rate. Following the recent base rate change announced by the Bank of England, our Standard Variable mortgage rate will increase to 7.44% per annum with effect from 1st February 2007.

The revised interest rate will be applied to your mortgage account from this date and your monthly payment will change from £1,907.84 to £2,007.70. 

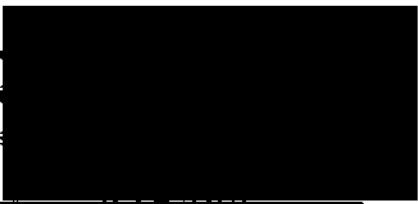

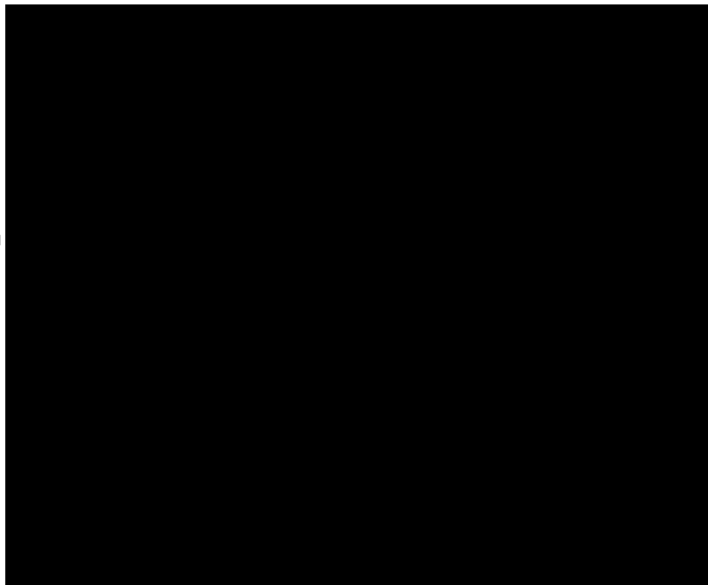
