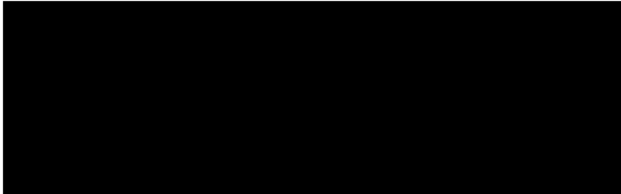
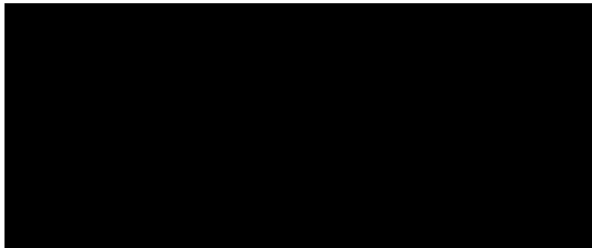

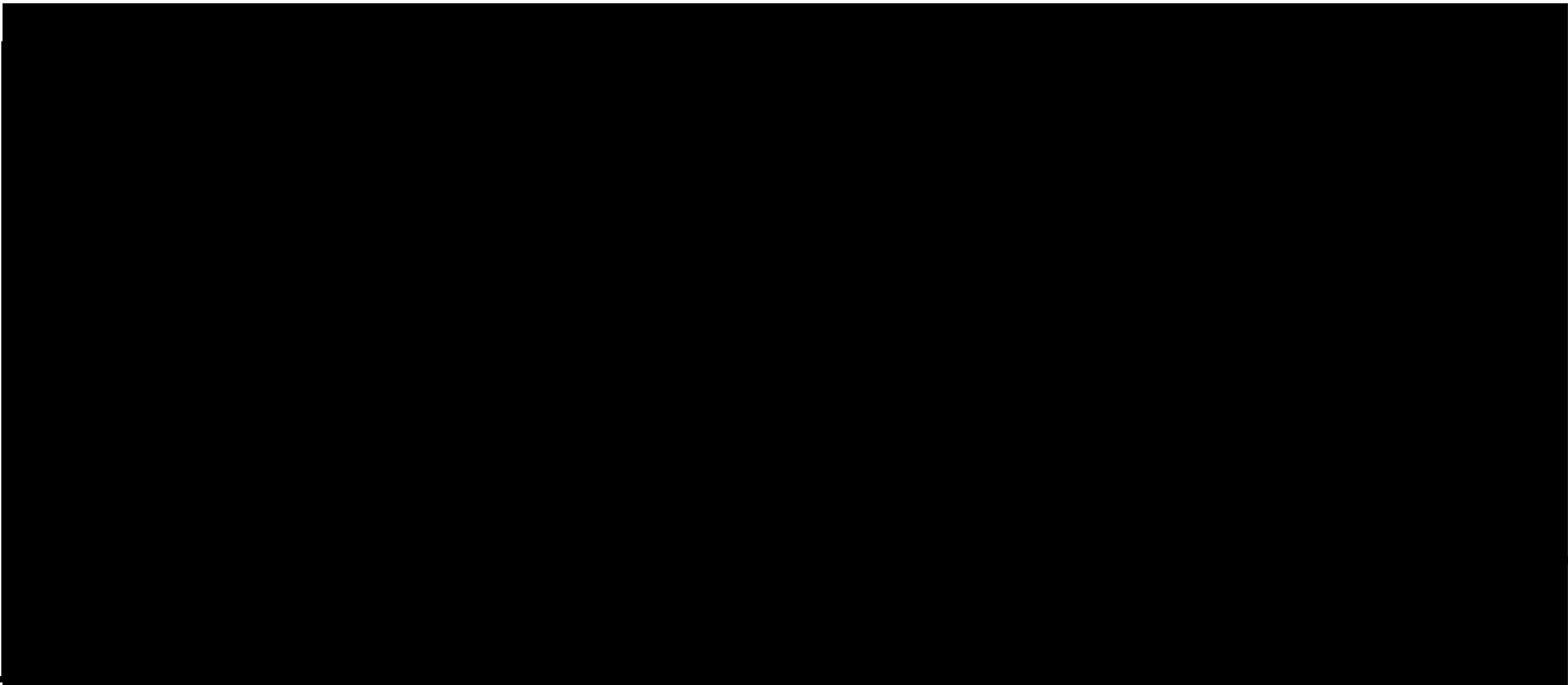

Bill for 2007/08

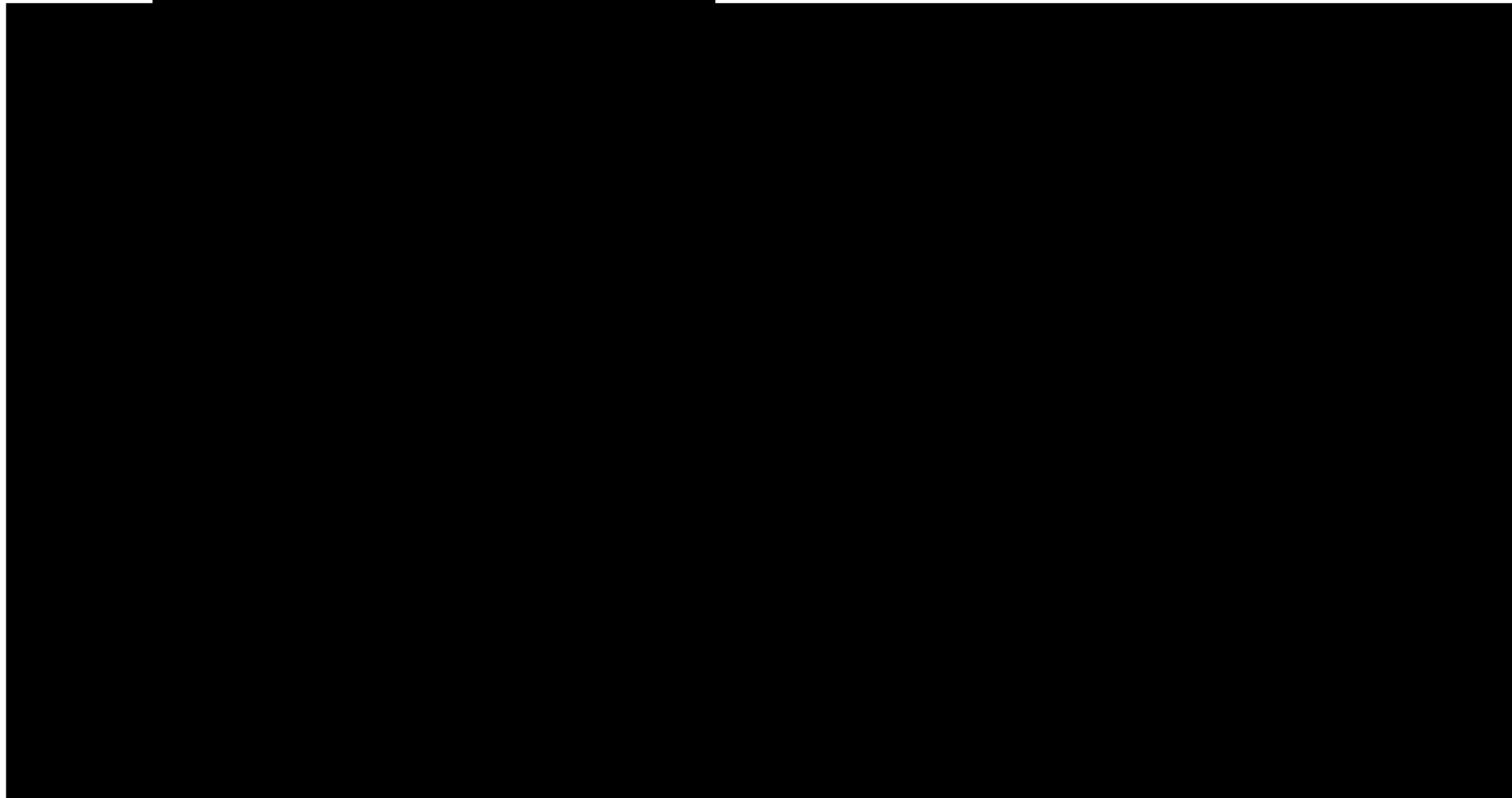
