



The previous rent was £1225.21.

The new rent is £1278.33 from 19th February 2008.

Currently outstanding on the account is:


£33.12 which was not paid at the time of a previous renewal.

£19.21 which is the increase in rent for the period 19th to 29th February.

However, you have also already paid for the period $1^{st} - 31^{st}$ March, but at the old rent of £1225.21, leaving £53.12 unpaid.

Therefore, in order to be completely up to date until the end of March, we would need payment of £105.45 (33.12 + 19.21 + 53.12).

The next payment due would then need to enter our account on the 1st April, meaning you need to cancel your current standing order of £1225.51 sent on the 1st of each month, and set up a new standing order to start on the 28th March and repeat on the 28th of each subsequent month
