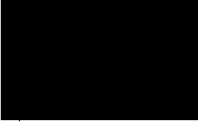

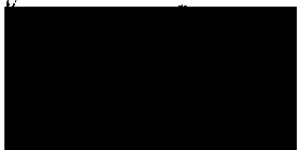
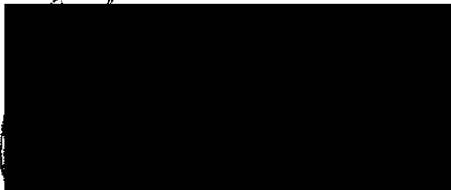
Dear Sian,
